### **OUTSTANDING PUBLIC ADMINISTRATOR OF THE YEAR 2012**

The Outstanding Public Administrator of the Year Award recognizes a Nebraskan currently working as a public administrator. Nominations should cite the nominee's noteworthy contributions to public service through their organization's goals and objectives. The nominee should demonstrate a tradition of excellence through outstanding achievements, a commitment to professionalism, exceptional leadership qualities, high ethical standards and a devotion to public service and democratic ideals.

### **OUTSTANDING NON-PROFIT ADMINISTRATOR OF THE YEAR 2012**

The Outstanding Non-Profit Administrator of the Year Award recognizes a Nebraskan currently working as a non-profit administrator. Nominations should cite the nominee's noteworthy contributions to the non-profit sector through their organization's goals and objectives. The nominee should demonstrate a tradition of excellence through outstanding achievements, a commitment to professionalism, exceptional leadership qualities, high ethical standards and a devotion to non-profit ideals.

To nominate an individual, the attached form must be completed and returned along with a description detailing support for the nomination. The award category should be clearly marked. *We strongly prefer that the nominator present the award to the recipient at the ASPA Nebraska Annual Awards Luncheon, which is scheduled for Thursday, April 26, 2012.* The ASPA award committees will let the nominator know when it has received the nomination and when a recipient has been chosen.
